This form must be accompanied by the responsible financial party's current bank statement or a letter from the sponsor's bank or other appropriate financial statement.

Acceptable financial documents may be any of the following, so long as they show that you have the necessary funds available. If the documents you are submitting are not in English, a certified English translation must be attached to the original.

- An official bank statement for a savings, checking, or time deposit account in your or your sponsor's name. Bank statements must clearly show the account holder's name, the name of the banking institution, and must be dated within 6 months from the date of submission. **We DO NOT consider** investment, retirement accounts, payroll reports/expected income, Tax statements & W-2s, property assessments, and credit cards.
- If you will be supported by a private sponsor (family member, friend, or private institution), the sponsor must complete and sign and fill out the Responsible Party Information.
- Letter of financial support or financial guarantee document from government sponsor or foreign embassy that specifies Concordia University Irvine as the student's school, the validity period of financial support, and the amount provided.
- An official scholarship award letter addressed to you or Concordia University Irvine and specifying the amount and validity period of financial support.
